Notice of Race SCCYC and Lido 14 Fleet 2 Present **The 2011 Lido 14 Fleet 2 Championships** Saturday, October 1st, 2011



Rules: This series will be governed by the Racing Rules of Sailing for 2009-2012 and the rules of the Lido 14

Eligibility: Only members of Lido 14 Fleet 2 are eligible to compete in this event.

Entry: The entry fee is \$12 and includes a post-regatta BBQ. \$2 discount for US Sailing members. Make checks payable to SCCYC. Entrants must complete and deliver the attached Entry Form to SCCYC by Saturday, October 1*, 2011 at 1000 hours. Race entries may deposited in the race entry box (mailbox) on the southwest wall, near the bottom of the stairs to the SCCYC Club House or mailed to: SCCYC, 13445 Mindanao Way, Marina del Rey, CA 90292.

Sailing Instructions: Sailing Instructions will be available at SCCYC no later than 0930 hours the day of the race. There will be no division of A and B fleets. All boats will race together.

Skippers' Meeting: A skippers' meeting will be held at SCCYC at 1030 hours the day of the race. Any notices to competitors will be given at that time.

Starting Time & Location: The first race will start at 1200 hours. Racing will be inside Marina del Rey harbor between the "No Sail" lanes of the outer entrance channel.

Parking: Car and trailer parking is available at SCCYC for free, or at the public launch ramp parking lot for a fee.

Launching: Hoist is available at SCCYC for boats that have their own internal lifting sling. A public launch ramp is also available across the street from SCCYC for a fee [\$7.00]. Entrance is machine operated, and exact change is suggested.

Awards: Trophies and awards will be presented at SCCYC following the last race.
