SCCYC and Lido 14 Fleet 2 invite Lido 14 Class Association members and guests of Lido 14 Fleet 2 are eligible to compete in the 8th Annual Fleet 2 Invitational.



Rules: This series will be governed by the Racing Rules of Sailing for 2009-20012.

Eligibility: All members of the Lido 14 Class Association and guests of Fleet 2, are eligible to compete.

Divisions: Lido A and B, Coronado 15s and Lasers are expected. The divisions will race separately. Other classes are welcome, 3 boats required for a start.

Entry: The entry fee is \$15 (\$10 for Lasers) and includes a post-regatta BBQ, checks payable to SCCYC. Entrants must complete and deliver the attached Entry Form to SCCYC by Saturday, March 31st, 2012, at 10:30 am. Race entries may deposited in the race entry box on the Southwest wall at SCCYC or mailed to: SCCYC, 13445 Mindanao Way, Marina del Rey, CA 90292.

Sailing Instructions: Sis will be available at SCCYC no later than 1030 hours the day of the race.

Skippers' Meeting: A skippers' meeting will be held at SCCYC at 1030 hours the day of the race. Any notices to competitors will be given at that time.

Starting Time & Location: The first race will start at 1200 hours. Racing will be inside Marina del Rey harbor between the "No Sail" lanes of the outer entrance channel.

Parking: Car and trailer parking is available at SCCYC for free, or at the public launch ramp lot for a fee.

Launching: Hoists are available at SCCYC for boats that have their own internal lifting sling. A public launch ramp is also available across the street from SCCYC for a fee (\$7.00). Entrance is machine operated, and exact change is suggested.

Awards: Trophies and awards will be presented at SCCYC following the last race.
