South Coast Corinthian Yacht Club (SCCYC) and Lido 14 Fleet 2 invite Lido 14 Class Association members and guests of Lido 14 Fleet 2 to compete in the 2nd Annual Fleet 2 Invitational & 2006 District I Championship Regatta.

**Rules:** This series will be governed by the Racing Rules of Sailing for 2005-2008.

**Eligibility:** All members of the Lido 14 Class Association and guests of Fleet 2, are eligible to compete in this event. Members of Lido 14 District I competing in the Lido 14 A division will be eligible for the honor award of 2006 District I Champion.

**Divisions:** Lido A and B divisions are provided. The divisions will race separately.

**Entry:** The entry fee is \$15 and includes a post-regatta BBQ. Make checks payable to SCCYC. Entrants must complete and deliver the attached Entry Form to SCCYC by Saturday, April 22, 2006, at 1000 hours. Race entries may deposited in the race entry box (mailbox) on the southwest wall, near the bottom of the stairs to the SCCYC Clubhouse, or mailed to: SCCYC, 13445 Mindanao Way, Marina del Rey, CA 90292.

**Sailing Instructions:** Sailing Instructions will be available at SCCYC no later than 0900 hours the day of the race.

**Skippers' Meeting:** A mandatory skippers' meeting will be held at SCCYC at 1000 hours the day of the race. Any notices to competitors will be given at that time.

**Starting Time & Location:** The first race will start at 1200 hours. Racing will be inside Marina del Rey harbor between the "No Sail" lanes of the outer entrance channel.

**Parking:** Car and trailer parking is available at SCCYC for free, or at the public launch ramp parking lot for a fee.

**Launching:** A hoist is available at SCCYC for boats having their own internal lifting sling. A public launch ramp is also available across the street from SCCYC for a fee (\$7.00). Entrance is machine operated, and exact change is suggested.

**Awards:** Trophies and awards will be presented at SCCYC following the last race.
