




## South Coast Corinthian Yacht Club and Lido 14 Fleet 2 Present

Rules: This series will be governed by the Racing Rules of Sailing for 2013-2016.

Eligibility: All members of the Lido 14 Class Association and guests of Fleet 2 are eligible to compete.

**Divisions:** Lido A, Lido B and Coronado 15 divisions are expected. The divisions will race separately.

Entry: Your entry fee of \$20 includes pre and post-regatta refreshments, outstanding racing, spectacular awards and access to our cash bar. The Registration Desk is open from 0800 to 1030 the day of the regatta. To facilitate the registration process, please use the RSVP link at Lido14.com

Sailing Instructions: SI's will be available at SCCYC no later than 1030 hours the day of the race.

Skippers' Meeting: A skippers' meeting will be held at SCCYC at 1030 hours the day of the race. Any notices to competitors will be given at that time.

Starting Time & Location: The first race will start at 1200 hours. Racing will be inside Marina del Rey harbor between the "No Sail" lanes of the outer entrance channel.

Parking: Car and trailer parking is available at SCCYC for free. Request a parking pass upon arrival.

Launching: A hoist (with our signature hoist & trailer valet service) is available at SCCYC for boats that have their own internal lifting sling. A public launch ramp is also available across the street from SCCYC for a \$10 fee. This entrance is machine operated, and exact change is suggested.

Awards: Trophies and awards will be presented at SCCYC after racing.
