Divisions: Lido A, Lido B and Coronado 15 divisions are expected. The divisions will race separately.

Entry: Your entry fee of \$20 includes pre and post-regatta refreshments, outstanding racing, spectacular awards & raffle and access to our cash bar. Registration is open from 0800 to 1030 the day of the regatta.

Starting Time & Location: The first race will start at 1200 hours. Racing will be inside Marina del Rey harbor between the "No Sail" lanes of the outer entrance channel.

Launching: Our signature hoist & trailer valet service is available at SCCYC for boats that have their own internal lifting sling.

Awards: Trophies and awards will be presented at SCCYC after racing.
