Rules: This regatta will be governed by the Racing Rules of Sailing.

Eligibility: This regatta is restricted to members of Lido 14 Fleet 2 and Coronado 15 Fleet 2.

Divisions: There will be a single Division for each Class.

Entry: Your entry fee of \$10 includes pre and post-regatta refreshments, outstanding racing and access to our cash bar. Please register at SCCYC between 0800 and 1030 the day of the regatta.

Sailing Instructions: SI's will be available at SCCYC no later than 1030 hours the day of the race.

Skippers' Meeting: A skippers' meeting will be held at SCCYC at 1030 hours the day of the race. Any notices to competitors will be given at that time.

Starting Time & Location: The first race will start at 1200 hours. The starting area will be inside the Marina del Rey detached breakwater between the "No Sail" lanes of the outer entrance channel.

Parking: Car and trailer parking is available at SCCYC for free. Request a parking pass upon arrival.

Launching: A hoist is available at SCCYC for boats that have their own internal lifting sling. A public launch ramp is also available across the street from SCCYC for a \$10 fee. This entrance is machine operated, and exact change is suggested.

Awards: Trophies and awards will be presented at SCCYC after racing.
